The undersigned makes oath that the applicant shall not engage in the transportation, storage, sale, distribution, possession, receipt or manufacture of a beer of alcoholic content as defined by T.C.A. §57-5-101(b), except at the place or places for which the Beer Board of Pigeon Forge, Tennessee, has issued a permit or permits to such applicant.

The undersigned further makes oath as follows:

- a. That no sale of alcoholic beverages shall take place for the purpose of consumption on the business premises of the applicant.
- b. That no person, firm, corporation, joint stock company, syndicate, or association having at least a five (5%) percent ownership interest in the applicant has been convicted of any violation of the laws against possession, sale, manufacture, or transportation of beer or other alcoholic beverages or any crime involving moral turpitude within the past ten (10) years.
- c. That no sale of such beverages shall be made except in accordance with the permit granted.
- d. That in the event a license is issued to the applicant, the business of the applicant shall make no more than twenty-five (25%) percent of its total gross sales in alcoholic beverages as defined by T.C.A. §57-5-101(b), to be determined monthly.
- e. That applicant shall file a written report on a monthly basis with the City Recorder of the City of Pigeon Forge, Tennessee, as evidence that no more than twenty-five (25%) percent of the gross sales of the business are due to the sale of alcoholic beverages as defined by T.C.A. §57-5-101(b).
- f. That the business premises of the applicant is not located within 150 feet of any church or school measured from the closest point of each of the respective buildings.
- g. That the applicant will within ten (10) days after being issued a permit to sell, distribute or manufacture beer, file with the City Recorder and with each person from whom the person buys beer, a copy of a valid certificate indicating that the purchases of beer are “for resale” as that term is defined herein, and shall subsequently maintain at all times a valid resale certificate on file with the City Recorder and with each person from whom that person buys beer.
- h. That all city and county property taxes, license fees or other charges by the City of Pigeon Forge or Sevier County, Tennessee, are current and shall in the future be paid on or before the due date therefore.
- i. That no sales of alcoholic beverages shall take place by way of a drive-through window.
- j. That no sales shall be made to persons under the age of twenty-one (21) years.

- k. That the applicant has not had a license for the sale of alcoholic beverages of any kind or nature revoked by any city, county, or state.
  - l. That applicant shall not advertise the sale of beer by any means, by billboard, television, exterior signage, radio or other communication, off the business premises and shall not advertise the prices for beer. Only two (2) interior signs visible from the exterior of the business premises advertising the availability of beer shall be allowed, and such signs shall not exceed two feet by two feet. Only one (1) outdoor sign, advertisement, or display that advertises beer may be erected or maintained on the premises, but said sign cannot have brand names, pictures, numbers, prices, or diagrams relating to beer located thereon.
  - m. That in the event the applicant's restaurant/eating place contains a bar area, food service shall be available to the bar areas as it would be in other areas of the restaurant/eating place.
  - n. That the applicant shall not offer for sale or sell beer at any time and on any day when the sale of liquor, wine and/or mixed drinks are prohibited by the prevailing rules of the Tennessee Alcoholic Beverages Commission ("TABC").
  - o. That the premises of the applicant meets all fire safety standards of the City of Pigeon Forge relative to occupancy by the public and the same has been inspected by the City of Pigeon Forge Fire and Building Inspection office in conjunction with this application.
  - p. All persons employed or to be employed by the applicant in the distribution or sale of such beverages must meet all Tennessee Alcoholic Beverages Commission (TABC) requirements for such distribution or sale, and it is the applicant's responsibility to ensure that all persons employed by them for these purposes meet the requirements.
12. The applicant shall execute an authorization enabling the City of Pigeon Forge to receive from each and every wholesale supplier to the holder of the permit, the dollar value and amounts of beer sold by the wholesaler or distributor to the holder of the permit at such time or times as the City may request such information. This authorization shall be in full force and effect during the entire term of the permit.

By affixing its signature to this application, the applicant hereby authorizes the City of Pigeon Forge to receive from each and every wholesale supplier to the holder of the permit, the dollar value and amounts of beer sold by the wholesaler or distributor to the holder of the permit at such time or times as the City may request such information. This authorization shall be in full force and effect during the entire term of the permit.

**NOTICE REGARDING FINGERPRINTING**

**By applying for a beer permit, applicant hereby agrees to be fingerprinted. Applicant shall bear the cost of fingerprinting. Applicant understands that the fingerprints provided will be used to check the FBI's criminal history records for applicant. Applicant further acknowledges that he/she has been provided a copy of the City's Noncriminal Justice Applicant's Privacy Rights' statement.**

**Applicant will be notified if the criminal history check reveals any history in order for applicant to take necessary steps to address any information which applicant believes could be false or inaccurate. Applicant should consult 28 C.F.R. 16.34 which sets forth the procedure for obtaining a change, correction, or update to a FBI criminal history record. Applicant's application will be placed on hold if the City is notified that applicant wishes to have time to address any history reported as a result of the fingerprint processing.**

**The City will use the criminal history record obtained SOLELY for the purpose of processing the application for a beer permit and cannot disseminate the record outside of the Office of the City Manager, Pigeon Forge Police Department, the Beer Board, and any other related agency or entity who is required to be involved in reviewing and considering an application for beer permit.**
