## SPECIFICATIONS FOR REFINISHING THE GYM FLOOR AND TWO RACQUETBALL COURTS AT THE PIGEON FORGE COMMUNITY CENTER

The following specifications are minimum acceptable standards. Any deviation from these specifications should be submitted in writing for consideration and approval by the Building Maintenance Supervisor.

### SPECIFICATIONS

**Product:**

45% marathane

**Floor Preparation:**

Initially the floor should be aggressively screened with 120 grit sandscreen disk. Upon completion of screening, the floor will be tack free of dust and debris

**Application:**

Apply 2 coats of 45% marathane to the entire court surface  
Proper circulation of air will be used to counter the effect of strong fumes

**Time Frame:**

The work must begin on Tuesday, August 7<sup>th</sup> and be completed by 5pm, Friday, August 10<sup>th</sup>, 2012.

**Warranty:**

All work is to be guaranteed against any defects of products or workmanship for a period of one (1) year.

To insure accuracy of your bid you are encouraged to schedule an appointment to verify the square footage and other necessary information during the hours of 8:30 a.m. and 4:30 p.m., Monday-Friday by calling Alan Loy, Building Maintenance Supervisor at 865-850-4728.
