The Pigeon Forge Police Department is requesting bids from qualified vendors for Protective Masks. The specifications for these Protective Masks are attached. Bid specifications may be obtained at the Pigeon Forge Police Department Monday through Friday between the hours of 8:00 a.m. to 4:30 p.m. Proposals not meeting the requirements will be rejected.

The City of Pigeon Forge reserves the right to reject any or all bids or to accept the bid deemed most favorable to the City. We also reserve the right to accept any portion or all of a bid.

The bid may be extended in one year increments up to three years by agreement of both parties. The bid may be cancelled due to bidder not meeting delivery requirements (30 days from order placement) or not meeting pricing obligations. Orders and measurements for an individual officer must be taken at the Pigeon Forge Police Department to insure accurate sizes.

Quotation must reflect differences in prices, sizes/male and female, and brands if such difference exists. Any and all shipping and/or handling charges will be included in the bid price.

Bidder agrees by placing a bid that no bills will be submitted to the Pigeon Forge Police Department until all items on order are received and accepted by the Pigeon Forge Police Department as correct. Delivery does not constitute acceptance. Bidder must include a W-9 with the bid submission.

Bidders shall not add any conditions or qualifying statements to this bid, except as provided herein, as otherwise the bid may be declared irregular as not being responsive to the Advertisement for Bids.

### **INFORMATION FOR BIDDERS**

#### QUALIFICATIONS OF BIDDERS

The City of Pigeon Forge (herein referred to as the "Owner") may make such investigations as he/she deems necessary to determine the ability of the bidder to supply the necessary equipment, and the bidder shall furnish to the Owner all such information and data for the purpose as the Owner may request. The Owner reserves the right to reject any bid if the evidence submitted by, or investigation of, such bidder fails to satisfy the Owner that such bidder is properly qualified to carry out the obligation of the contract by supplying the equipment contemplated therein. Conditional bids will not be accepted.

#### QUANTITIES AND LENGTH OF CONTRACT

This bid is for an approximate one (1) year period from the date of award and may be renewed on an annual basis in one (1) year increments up to three (3) additional years if all terms, conditions, and prices remain unchanged and both parties are in agreement. Prices contained herein are to be firm for the term of the contract and can be extended to other local governments. The owner reserves the right to re-bid anytime during the term of the contract.

#### **OBLIGATION OF BIDDERS**

At the time of the opening of bids, each bidder will be presumed to have read and to be thoroughly familiar with the specifications. The failure or omission of any bidder to examine all the forms, instruments, and documents shall in no way relieve the bidder from any obligation in respect to his/her bid. "By submission of this bid, each bidder and each person signing on behalf of any bidder certifies, and in the case of a joint bid each party thereto certifies as to its own organization, under penalty of perjury, that to the best of its knowledge and belief that each bidder is not on the list created pursuant to 12-12-106".

#### VENDOR INFORMATION AND MANUALS

All equipment offered under this bid shall be new and unused and of the latest model year available from the manufacturer. The product offered for bid shall meet or exceed the specifications attached to this bid package and shall be considered as minimums unless otherwise indicated. Adequate vendor information shall be included with the bid for determination of meeting the specifications. Any exceptions shall be explained in writing and submitted as a part of the bid package.

#### WARRANTY

The product shall be warranted by the factory to be free of defects in material and workmanship for a minimum of five (5) years. Additional years of warranted shall be listed with associated cost.
