PLANNING COMMISSION

CALL TO ORDER

Chairman Bradley noted that a quorum was present.

APPROVAL OF MINUTES

The minutes of the January meeting were approved on a motion by Commissioner Dodgen. Commissioner Houser seconded and all voted in favor.

NEW BUSINESS

City of Pigeon Forge Items

A. Special Events

1. 5K in May –Smoky Mountain Area Rescue Ministries, from Veterans Blvd to City of Sevierville and back, Saturday, May 3, 2014, Elise Collier-Massey.

Ms. Collier-Massey was present.

STAFF RECOMMENDATION

Mr. Taylor stated that there were concerns with parking across the street from the starting line and stated they need to work with the Police Department to assure the safety of the participants.

ACTION TAKEN

Commissioner Dodgen made a motion to approve the event based on staff recommendation. Commissioner Harrell seconded and all voted in favor.

2. Spring & Fall Pigeon Forge Rod Run, LeConte Center, Teaster Lane, Spring (Friday April 11 through Saturday April 12) and Fall (Thursday, September 11 through Sunday, September 13), 2014, Rod Milligan.

Mr. Milligan was present.

STAFF RECOMMENDATION

Mr. Taylor explained that certain rules must be followed during the rod run including: 1. No car haulers in City Parking Lot except for in designated area. Signs will be erected and violators will be subject to towing. 2. Check on use of dumpster. 3. Keep front and rear entrance to Events Center open for emergency vehicles. 4. Keep roadway around the show area open for emergency vehicles.
