Position Title: Water Plant Supervisor, Full-Time

Job Description This is very skilled technical and supervisory work involving the operation of water pumping and purification equipment located in the water treatment plant for the City of Pigeon Forge. Activities associated with the job include but are not limited to:

- Supervising and assisting plant personnel with monitoring and adjusting plant operations.
- Establishes and implements effective operational policies and procedures to coordinate water treatment plant operations.
- Responds to plant emergencies and provides assistance to shift operators to remedy the situation(s).
- Oversees and assists with ensuring the proper functioning of water pumps, motors, chlorinators, filters and chemical feeders and making adjustments as necessary to maintain the proper flow of water.
- Compiles and maintains reports on water pumped for monthly and daily averages and related information and submits to state authorities as required.
- Oversees and assists with readings on meters and indicators, charts on recording meters and gauges. and collection of water samples from designated points.
- Oversees and assists with making physical checks and running chemical tests including temperature, turbidity, chlorine, alkalinity, pH, hardness, fluoride, CO2, iron, manganese, and bacteriological tests.
- Inspects chemical feeding and filtering equipment, prepares reports of findings and notifies the appropriate personnel of identified maintenance and repair needs.
- Interacts with suppliers and obtains quotes for chemicals, parts and equipment when necessary.

Minimum Qualifications: Graduation from an accredited four year high school and a valid certificate as a Water Treatment Plant Operator at the Grade IV level and considerable experience in water treatment plant operations required; three years of supervisory experience is required; thorough knowledge of the repair and maintenance of the mechanical, hydraulic and electrical components of water treatment plants; thorough knowledge of the occupational hazards and necessary safety precautions of the work; skill in the use of hand and power tools utilized in adjusting system and plant components; strong organizational, interpersonal and decision making skills; Valid Tennessee Driver's license required.
