SCOPE OF WORK

Removal and disposal of approximately 1500 square feet of glued down carpet, remove 55 LF of rubber glue down baseboard. Scrape glue and backing. Skim floor. Patch and level areas as needed.

Installation of approximately 1500 square feet of Mohawk Ultimate Step tile, approximately 210 LF of oak ¼" round toe molding stained to match the existing trim and 55 LF of rubber baseboard.
