

**MINUTES OF
CITY COMMISSION MEETING
MONDAY, OCTOBER 27, 2014, 5:30 P.M.
CITY HALL, PIGEON FORGE, TENNESSEE**

Mayor Wear called the meeting to order with the following in attendance: Vice Mayor McClure, Commissioner Brackins, Commissioner Ogle, Commissioner Reagan, City Manager Teaster, City Recorder Clabo, City Attorney Gass, and interested citizens.

Mayor Wear opened the meeting and Vice Mayor McClure led in the pledge of allegiance.

REGULAR MEETING

The minutes were unanimously approved following motion by Commissioner Brackins and second to motion by Vice Mayor McClure.

Mayor Wear asked if there were any comments from citizens.

No comments were received.

The authorization for the payment of bills was presented for approval. On a motion by Vice Mayor McClure, second by Commissioner Ogle, it was unanimously approved to accept the bills as presented.

Old Business

There was no old business.

New Business

Discussion and consideration of bid for two ½ ton 4x4 pick-up trucks for the Utility Department was presented for approval. Public Works Director Miller presented and stated four bids had been received and he recommended the low bid from Rocky Top Chrysler Jeep at a cost of \$22,278 each for a total of \$44,556. On a motion by Vice Mayor McClure, second by Commissioner Brackins, it was unanimously approved to accept the bid as presented.

Discussion and consideration of bid to purchase janitorial and paper supplies for the Building Maintenance Department from Ellison Sanitary Supply, Buckeye Cleaning, and JanPak was presented for approval. Parks and Recreation Director Wilbanks presented and recommended that the bid be awarded as follows: 1) Category 1 – Sanitary Supplies to Ellison Sanitary Supply at a cost of \$18,506.79; 2) Category 2 – Breakroom Supplies and Can Liners to Ellison Sanitary Supply at a cost of \$14,272.63; 3) Category 3 – Chemical Cleaning Products to Buckeye Cleaning at a cost of \$2,765.84; and 4) Category 4 – Bulk Products for can liners and roll towels to Ellison Sanitary Supply at a cost of \$14,820.24 and Category 4 toilet tissue to JanPak at a cost of \$2,836.80. On a motion by Vice Mayor McClure, second by Commissioner Ogle, it was unanimously approved to accept the bid as presented.

Manager's report included the following:

1. There will be a planning commission meeting on Tuesday October 28, 2014 at 3:00 p.m. in the council room at City Hall.
2. There will be a ribbon cutting ceremony for the Forever Parks Playground on November 5, 2014 at 12:00 p.m.
3. There will be a Veterans Parade and the kickoff of Winterfest on November 11, 2014 at 3:30 p.m.
4. Community Night will be held November 13th at the Pigeon Forge High School between 4:30 p.m. and 7:30 p.m.
5. There will be a countywide Winterfest dinner to celebrate 25th anniversary of Winterfest on November 3rd at 6:00 p.m. at the Holiday Inn.
6. The Halloween event at the Community Center will be Thursday October 30, 2014 beginning at 6:00 p.m.

Mayor Wear asked for comments from the board.

Mayor Wear thanked everyone that helped with the Celebrators event.

Having no other comments received, the meeting was duly adjourned at 5:35 p.m.
